## **ELECTION INTEGRITY**

- Eliminate the Wisconsin Election Commission (WEC) and full empower the office of Secretary of State (SoS) for election administration and oversight.
- Clarify all standing election laws that all forms of "ballot harvesting," "unattended drop boxes," "mobile ballot drops" (vehicular based) and/or any like attempts to undermine election integrity are illegal and strictly prohibited.
- Immediately clean voter rolls of dead, ineligible, moved or otherwise ineligible voters. Clarify existing law that historic records of such voters do not and should not be included in the active voter lists.
- Expand election records retention. Extend ability to file election complaints to children of adults adjudicated incompetent to vote
- Eliminate \$!2,500 cost to access voter database.

## **ECONOMY**

- Refuse Federal taxpayer dollars that require the adoption of rules, laws or precepts that infringe upon the rights of Wisconsinites (Red Flag gun laws; past examples like the 55 MPH speed limit)
- Cut income taxes
- Eliminate phony phone tax
- Eliminate personal property tax
- Pass law requiring that the state budget bill be prepared according to Generally Accepted Accounting Principles (GAAP)
- Require a statement of estimated interest accruing on the amount of a bond when proposing a referendum to issue a bond.
- Reform the state revenue code to reduce onerous, unappealable nature of tax fines, fees and interest at the state level

- Michels must divest of financial interest and bidding interests of Michels Corp., while serving in office.
- Michels Corp should not serve as main contractor on WI government contracts while in office but could be a subcontractor as long as not involved in award process.

#### **EDUCATION**

- Commit to establishing Universal School Choice statewide without economic limitations for qualification and without ability for public school districts to raise levies on taxpayers for voucher students they are not educating
- Legally establish a Parents Bill of Rights guaranteeing complete curriculum and educational transparency
- No men in women's sports and vice versa; use bathroom of biological sex bill; schools can't attempt to surreptitiously facilitate change of students gender identity

## **SECOND AMENDMENT/CRIME & SAFETY**

- Commit to refuse Federal taxpayer dollars that would require the state of Wisconsin to adopt any restrictions upon the 2<sup>nd</sup> Amendment right to keep and bear arms. This would include, but not be limited to so-called Red Flag gun law/restrictions
- Constitutional Carry law
- Emplace mandatory minimum bail and sentencing for violent charges and convictions.
- No support marijuana legislation/any recreational drugs
- Increase penalties for sex trafficking/human trafficking (2021 SB 26 & 2021 SB 836)
- Requiring recommendation to revoke extended supervision, parole, or probation if a person is charged with a crime (2021 SB 188)

# MEDICAL FREEDOM

- Pass legislation ensuring medical freedoms of Wisconsinites.
- Pass legislation preventing future state and county officials from enacting COVID-19-like lockdowns ever again in Wisconsin.
- Ban gender transition/mutilation for minors; no men in women's sports; use bathroom of biological sex bill; schools can't attempt to surreptitiously facilitate change of students' gender identity

- No discrimination on the basis of vaccination status (not just restricted to COVID vaccine either)- 2021 SB 336 & 2021 SB 337/
- Right to try off-label therapies/ Informed consent for pelvic exams (2021 SB 127)/ stop ESG

#### **SANCTITY OF HUMAN LIFE**

- Pledge to maintain current law without allowing for further exceptions.
- End Medicaid Abortion Provider (Planned Parenthood) funding and UW sponsored abortion training (in or out of state), no abortion facilitation by public employees within scope of their employment
- Reform adoption laws to allow for out-of-court consent process for termination of parental rights (bring WI into mainstream in allowing this, not adoption friendly currently) to include parents bill of rights and a foster parents bill of rights.
- Commit to fire DAs/Sheriffs who refuse to prosecute Wisconsin's pro-life laws

#### **AGRICULTURE:**

- Advocate for trade policies that allow farmers to get products to all relevant markets.
- Revise and/or eliminate onerous environmental regulation that unnecessarily harms the agricultural industry
- Emplace, facilitate and/or encourage programs in public and private schools provide a career path and practical training for an agriculture career and the trades that support it.

## NATIONAL SECURITY/SOUTHERN BORDER/ILLEGAL IMMIGRATION:

- Refuse to "re-settle" illegal immigrants in state of Wisconsin.
- Institute program like Texas and Arizona to offer relocation of illegal immigrants brought to Wisconsin by the Federal Government in Washington, D.C., New York City, Dover, DE and/or any other self-proclaimed sanctuary cities.
- Respond to calls for help securing the border made by border states through the deployment of the Wisconsin National Guard where and when applicable.
